# 1. CALL TO ORDER, QUORUM CHECK

# 4. DISCUSS, CONSIDER, AND TAKE APPROPRIATE ACTION ON ORDINANCE 2020-3, AMENDING THE VILLAGE OF TIMBERCREEK CANYON CODE OF ORDINANCES CHAPTER 9 -- BUILDINGS

Katie Perkins explained that this will be the second reading of the full Ordinance and that the Ordinance may be voted on at this meeting. Bill Young provided the background on Ordinance 2020-3. It was noted that when changes were made to the Zoning Ordinance, parts of Section 8 were deleted. The changes in the Chapter 9 amendments, Section 9.08, relate to setbacks. Dickie Haney made the motion to approve Ordinance 2020-3, Amending the Village of Timbercreek Canyon Code of Ordinances Chapter 9 – Buildings. Mike Fuller seconded the motion and it passed unanimously.

### 5. BOARD MEMBER COMMENTS AND ESTABLISH FUTURE AGENDA ITEMS

Dickie Haney would like to hold the August Aldermen meeting in person. Brian Giffin suggested holding the meeting at the Fire Station to allow for social distancing, but it will probably be too hot.
