- A. 2 C.F.R. \$200.318(a) requires recipients to use their own documented procurement procedures which reflect applicable State, local, and tribal laws, and regulations, provided that the procurements conform to applicable Federal law
- B. 2 C.F.R. §200.318 .327. Failure to develop local procurement procedures to manage day-to-day compliance and/or not adhering to the current, and established procurement procedures may result in improper procurement transactions and possible return of funds
- C. 2 C.F.R. 200.318(i) recipients are required to maintain sufficient records to detail the history of procurement which include, but are not limited to, the rationale for the method of procurement, selection of contract type, contractor selection, and the basis for the contract price. Not maintaining all procurement documentation places the recipient at risk of questioned and disallowed costs.
